<u>OFFER OF APPOINTMENT FOR THE POST OF CONSTABLE(GD) IN BORDER SECURITY FORCE (BSF) THROUGH STAFF SELECTION COMMISSION (SSC) EXAM-2021</u>	
1. Please refer your application for the post of Constable(GD) through SSC Exam-2021 and final result published by SSC on 07.11.2022 on their official website.	
2. I am directed to inform you that, you have been PROVISIONALLY selected for appointment to the post of Constable(GD) in BSF in Pay Matrix Level-3 (pay scale Rs.21,700/- – 69,100/-) with initial Basic Pay of Rs.21,700/- per month plus other allowances admissible under rules from time to time. On behalf of the DG BSF & all ranks of Border Security Force, you are welcome to join the 'Elite Force', which has earned an enviable position for itself in the galaxy of "Border Guarding Forces" of the world, be it in peace or in war.	
3. Your appointment to the above post is subject to the following terms and conditions:- The recruitment medical examination is valid for one year from the date of fitness to join the service and if candidate join the service after validity period of recruitment medical, candidate will be examined by the medical officer for any disease/deformity that might have arisen after the recruitment medical. Hence, if your recruitment medical has completed one year then you will be examined by the medical officer to detect/discover/disability/accidental injury acquired during the intervening period of recruitment (initial) medical examination and the date of joining. You will be allowed to join only on being found 'FIT'.	
(a) Your appointment is purely provisional till receipt of a 'no adverse' character and antecedents verification report from the concerned civil authorities. In the event of receipt of any adverse report from the civil authorities, your service will be terminated immediately without any prior notice. In case your character and antecedents is found not verified or any false information given by you in your self-declaration, the provisional appointment letter will be cancelled forthwith and other criminal/legal action will also be taken, as a consequence.

(b) You will be governed by the provisions of BSF Act-1968 and BSF Rules-1969 as amended from time to time and other Central Government Orders, Rules and Regulations, as applicable from time to time.

(c) You are entitled to get pensionary benefits as per new restructured "**DEFINED CONTRIBUTORY PENSION SYSTEM**" applicable for the new entrants to the Central Government service from **Jan 2004**. Therefore, you would make monthly contribution @10% on the basic pay and DA towards the new pension system from the date of appointment.

(d) Initially you will be on probation for a period of two years, which may be extended by the appointing authority for such further period or periods not exceeding one year, for reasons to be recorded in writing. During the period of probation, if the appointing authority considers that you are not likely to become an efficient member of the Force due to any reason, your services can be terminated without assigning any reasons or without any advance notice.

(e) The appointment carries liability to serve in any part of India and abroad.

(f) The post is temporary but likely to be made permanent in due course. In case the temporary post is abolished, your services shall be terminated without assigning any reason.

(g) You will undergo basic recruit training as per prescribed period. In case, you tender resignation from service within a period of 10 years for reasons other than accepting a job under Central or State Govt. or local bodies for which cadre clearance has been granted, your resignation may be accepted only after you refund training cost or 3 months pay and allowances last drawn by you or if you have not completed three months service on the basis of pay and allowances to which you are entitled in the month in which you tender your resignation whichever is higher.

(h) You are not entitled any traveling/daily allowance for joining BSF first time.

4. Your appointment will be further subject to:-

(a) Provision of Rules-7 of BSF Rules-1969 which envisages that no person: -

- (i) Who has entered into or contracted a marriage with a person having a spouse living or;
- (ii) Who, having spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment in the Force, provided that the Central Govt, may if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage there are other grounds for so doing exempt any person from the operation of this Rule.

(b) Taking of an oath of allegiance/faithfulness to the constitution of India (or making of a solemn or affirmation to the effect in Prescribed form).

In case, any of above conditions is not fulfilled, the Department will not entertain any claim for damages and other losses suffered by you.

- (ii) Certificate of education and other technical qualifications.
- (iii) Matriculation or equivalent certificate as proof of age.
- (iv) SC/ST/OBC Certificate issued by Tehsildar/SDO/SDM and above.
- (v) If you are serving in Government/Semi Government service, Discharge/release certificate from parent department in the prescribed format.
- (vi) Domicile certificate issued by Tehsildar/SDO/SDM and above.
- (vii) PAN Card, Aadhar Card and front page of Savings Bank account (SBI).

(d) The appointment is provisional and subject to the conditions mentioned above and your character and antecedents, education and the caste/tribe/OBC Certificate being verified through proper channel.
