Sir,

With reference to the above noted letters and subject, I have
to request you to note the following in the matter :-

1.(a) Creation of teaching posts :- It has been specifically laid
down in para (ii) of G.O.No. 1056.Edn(CS) dated 26.5.73 that the
college will be eligible for at least two whole-time teaching posts
(for each subject upto the 'Pass' Course) but such creation will
follow the Principles indicated by the University at the time of
sanctioning affiliation in the subject. It appears from the Burdwan
University's letter No. I/C/437/71 dated 25.10.71 that the condition
imposed for the creation of the 2nd post of lecturer in Commerce is
that it should be created with effect from the session 1972-73. Hence,
the creation of the 2nd post of lecturer in Commerce can not be
approved of with effect from a session earlier than 1972-73.

(b) The creation of the 1st. & 2nd. posts of lecturer in English,
History, Political Sciences, Philosophy and Sanskrit may be approved
of with effect from the sessions 1972-73 and 1973-74 respectively
provided the existing part-time posts in the said subjects are
abolished with effect from the session 1977-78.

(c) The creation of the 3rd post of lecturer in Bengali cannot be
approved of with effect from the session 1973-74 as it is not justified
by the workload. However, the same may be approved of with effect
from the session 1974-75.

(d) The creation of the 2nd post of lecturer in Economics can not
be approved of with effect from the session 1973-74 as a part of the
workload during that session was managed by a part-timer. It may be
approved of with effect from the session 1974-75.

2. As regards the cases of the teaching staff, the following points
may please be noted regarding appointment of Principal :-

(i) The post of Principal may be deemed to have been approved with
effect from the session 1971-72. As regards appointment of a Principal
to the said post, I would like to invite your attention to Sub-section
(2) of Section 3 of the W.B. Act XVII of 1976 read with the Schedules to
that Act and G.O.No. 670.Edn(CS) dated 9.7.75.

(ii) Re : Appointment of part-time lecturers : As a part-time lecturer is already working in the Department of Commerce, there is no justification for the appointment of another part-time lecturer. The existing part-time post of lecturer in the said Department will have to be abolished as soon as the post of Principal is filled up by regular appointment and Shri Sailendra Nath Sarkar, lecturer in Commerce is relieved of his duties as Professor-in-Charge of the college.

3. Re : Approval of appointment and fixation of pay of lecturers of the college :

(i) Re : Shri Upananda Roy, lecturer in Commerce.

(a) The pay shown against column 16(i) should be Rs.300/- in place of Rs. 350/- as per para 3 (iii) of G.O.No. 1554.Edn(GS) dated 8.9.76.

(b) The part-time work declaration and the non-employment declaration should be as per guidelines supplied to the college and explained to the Professor-in-Charge.

(ii) Re : Shri Sailendra Nath Sarkar, lecturer in Commerce.

(a) The pay shown against column 16(i) should be Rs.300/- in place of Rs. 350/- as per para 3 (iii) of G.O.No. 1554.Edn(GS) dated 8.9.76.

(b) A copy of the full text of the proceedings and recommendation of the Selection Committee, may please be furnished under the signature of the President of the Governing Body with the proceedings duly attested by the President of the Governing Body.

(c) The part-time work declaration and the non-employment declaration should be submitted by Shri Sailendra Nath Sarkar in the proper form as per guidelines supplied to the college and explained to the Professor-in-Charge and the said declarations should be got duly countersigned by the President of the Governing Body. All proposals and papers regarding the case of Shri Sarkar (Professor-in-Charge) may please be sent under the signature and attestation of the President of the Governing Body.

(iii) Re : Shri Chittaranjan Das, lecturer in English :

(a) An attested copy of the full text of the proceedings and recommendation of the Selection Committee may please be submitted.

(b) The part-time work declaration and the non-employment declaration should be as per guidelines supplied to the college and explained to the Professor-in-Charge.

(iv) Re : Shri Asok Kumar Batabyal, lecturer in English :

(a) The part-time work declaration and the non-employment declaration should be as per guidelines supplied to the college and explained to the Professor-in-Charge.

(v) Re : Shri Nisith Kumar Mukherjee, lecturer in Bengali :

(a) The date of joining of the date of substantive appointment does not seem to have been properly shown. It is not clear how a teacher could be appointed (or could be allowed to join) on 1.1.73, the 1st of January being a public holiday throughout the country. The date(s) of joining and substantive appointment should be shown correctly.

(b) The pay shown against column 16(i) should be Rs. 300/- in place of Rs. 325/- as per para 3 (iii) of G.O.No. 1554-Edn(CS) dated 8.9.76.

(c) An attested copy of the full text of the proceedings and recommendations of the Selection Committee may please be submitted.

(d) The part-time work declaration and the non-employment declaration should be as per guide line supplied to the college and explained to the Professor-in-Charge.

(VI) Re. Shri Debsapriya Basu, lecturer in Bengali.

(a) The part-time work declaration and the non-employment declaration should be as per guide line supplied to the college and explained to the Professor-in-Charge.

(VII) Re. Shri Rama Roy(Adak), lecturer in Bengali.

(a) It appears from the Governing Body resolution No.3 dated 9.4.74 that Shri Roy(Adak) was given second nomination by the Selection Committee which met on 11.3.74. The reason why the 2nd nominee was appointed in preference to the 1st nominee may please be stated. An attested copy of the full text of the proceedings and recommendation of Selection Committee may also be submitted.

(b) The part-time work declaration should be as per guide line supplied to the college and explained to the Professor-in-Charge.

(VIII) Re. Shri Mohini Mohan Manna, lecturer in Economics :

(a) Please see the remarks made in (a) against Shri N.K.Mukherjee. The case of Shri Manna is identical with that of Shri Mukherjee so far as the date of joining and substantive appointment is concerned. The position should be stated correctly.

(b) The pay shown against column 16(i) should be Rs. 300/- in place of Rs. 325/- as per Para 3 (iii) of G.O.No. 1554-Edn(CS) dated 8.9.76.

(c) The part-time work declaration and the non-employment declaration should be as per guide line supplied to the college and explained to the Professor-in-Charge.

(IX) Re. Shri Aswinya Kumar Mallik, lecturer in Economics :

The undersigned is directed, by the order of the Governor to say that the Governor is pleased to approve of the extension of affiliation in Physics, Chemistry and Mathematics in Higher Secondary level and in Degree (pane) level in Rabindra Mahavidyalaya, Champa Danga, Dist. Hooghly with effect from the current academic session (1980-81) subject to the grant of affiliation in those subjects by the West Bengal Council for Higher Secondary Education and by the University of Burdwan, as the case may be.

2. The Governor is also pleased to sanction payment during the current financial year of a non-recurring grant of Rs. 1,86,000/- (Rupees one lakh Eighty six thousand) only as detailed below to the Rabindra Mahavidyalaya, Champa Danga, Hooghly in connection with opening of science course in those subjects in the college:-

5. The charge will be met from the provision under the Head "University and other Higher Education-Assistance to the Non-Govt. Colleges -State Plan(Annual plan) Dev. of Non-Govt. Colleges-Grants-in-aid /contributions" in the 277-Education(excluding sports and youth welfare) Budget.

6. The Accountant General, West Bengal and the Sub-Treasury Officer, Chander, Hooghly are being informed.

- 12) that the intake in Nursing and Midwifery should not exceed 50 (fifty) for the present ;
- 13) that the provision for audio-visual method of teaching must be provided with a sum of Rs.5,000/- should be set apart for this purpose ;
- 14) that a fresh inspection will be held at the end of the academic session 1980-81 to assess the progress made by the college in fulfilling the above terms and conditions of affiliation. It is specifically mentioned that this affiliation is granted temporarily for a period of 1 (one) year and in case, the terms and conditions of affiliation mentioned above are not fulfilled within the stipulated period, the University will have the right and authority to withdraw the affiliation as granted.

This affiliation is subject to the provision of University Ordinances relating to conferment of degrees, titles etc. and the directions as may be given by this University from time to time.

- 4) that one Laboratory Assistant and one laboratory attendant each in Physics and Chemistry assist should be appointed from the session 1960-61 ;

- 11) that the equipments as per list enclosed (Annexure-II) should be purchased for the Chemistry Department ;
